STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-ONE.

AN ACT to divide the town of Camden.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. All that part of the town of Camden lying

- 2 northerly of the following described line, namely: begin-
- 3 ning on the shore of Penobscot Bay, on the original north
- 4 line of the Daniel Barrett farm; thence N. 45° W., by
- 5 said line, thirty-six hundred feet to stake and stones
- 6 at the head of "Lily Pond" (so called) in the southerly
- 7 line of the Jacob's farm (so called): thence north 29 deg.
- 8 and 40 min, west (nearly) by said Jacob's line and over
- 9 Union street one thousand, three hundred and ninety-seven
- 10 feet to the Carleton burying ground: thence northeasterly
- 11 on line of burying ground thirty-two feet to the easterly

12 corner thereof; thence north 29 deg. and 40 min. west by 13 line of said burying ground one hundred and forty-two 14 feet to the northerly corner thereof; thence southwesterly 15 on line of said burying ground thirty-two feet to Jacob's 16 line aforesaid; thence north 29 deg., 40 min. west on 17 said line one thousand, two hundred and forty feet to the 18 southeasterly side of the back road to Rockport; thence 19 north 61° west to summit of Ragged Mountain at a cop-20 per bolt set in the ledge by the United States Coast Sur-21 vey; thence to Hope line by a line parallel to the north 22 line of Rockland, together with the inhabitants thereof, is 23 incorporated into a separate town by the name of Camden, 24 and said town of Camden is hereby invested with all the 25 powers and privileges and subject to all the duties and 26 obligations incident to other towns of the State. 2? name of the residue of the town of Camden, southerly of 28 the line aforesaid, is hereby changed to Rockport.

SECT. 2. The several inhabitants of the town of Camden 2 shall be holden to pay all taxes which have been legally 3 assessed upon them by the town of Camden, and the collect-4 ors of taxes for said town of Camden are hereby authorized 5 and required to collect and pay all taxes to them already 6 committed according to their respective warrants. All 7 moneys now in the treasury of said town of Camden, and 8 all sums which shall hereafter be received from taxes 9 heretofore assessed, shall be applied to the several pur-10 poses for which they were raised, and in case of any 11 excess, said excess shall be applied by the treasurer of 12 Rockport in payment of the indebtedness of the original 13 town of Camden.

- The existing liabilities and obligations of the 2 town of Camden shall be divided as follows: The town 3 debt shall be borne by said towns in proportion to the 4 valuation of their respective territories, as taken by the 5 assessors in April, eighteen hundred and ninety, including 6 the property of the Camden Woolen Company and the 7 property of the Megunticook Woolen Company, at an 8 appraisal, ratable to the appraisal of property of similar 9 industries the same year. The obligations of the town of 10 Camden shall be borne by each town in the foregoing pro-11 portion, except its contracts with the Camden and Rock-12 land Water Company, which shall be borne by each town 13 in proportion to the number of hydrants used by each. 14 All paupers, now supported by the aid of the town of 15 Camden, shall, after division, be maintained and supported 16 by the town in whose territory they resided when they 17 became paupers. Each town shall henceforth bear all 18 expenses for the care and maintenance of all roads and 19 bridges within its respective limits.
- SECT. 4. The town farm of the town of Camden and all 2 personal property thereon shall be held and owned in 3 common by the said town of Camden and said town of 4 Rockport, in proportion to the valuation of their respective territories, and they shall sell and convey said farm 6 and personal property, at the request of either, and distribute the proceeds thereof between them, in the like 8 proportion, or may partition said farm according to law. 9 All the other real property of the town of Camden shall 10 be held and owned by the said town of Camden and Rock-11 port respectively, by the town where said property is 12 located. All the personal property of the town of Cam-

- 13 den shall be held and owned by the town in possession
- 14 thereof. The books and papers and records of the town
- 15 of Camden shall be retained by said town of Rockport,
- 16 and each town shall have access to the same. No com-
- 17 pensation for this apportionment of the real and personal
- 18 property of the town of Camden, is to be made by either 19 town.
- SECT. 5. The several school districts divided by this 2 act, shall be subject to all the provisions of law applicable 3 to school districts composed of parts of towns.
- SECT. 6. Any justice of the peace in the county of
- 2 Knox, may issue his warrant to any legal voter in the town
- 3 of Camden, directing him to notify the inhabitants thereof
- 4 to meet at a time and place specified in said warrant, giving
- 5 at least seven days' notice therefor, for the choice of town
- 6 officers, and to transact such business as towns are author-7 ized to do.
 - SECT. 7. This act shall take effect when approved.

REPORT "A".

The Committee on Towns to which was referred the petition of B. C. Adams and others praying that the town of Camden be divided have had the same under consideration, and ask leave to report that the petitioners have leave to withdraw.
