STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-ONE.

AN ACT to incorporate the Georges River Land Company.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

SECTION 1. Joseph E. Moore, William E. Vinal, C. S.
2 Smith, N. C. Mehan, C. W. Stimpson, Atwood Leven-
3 saler, J. H. H. Hewitt, J. O. Robinson and T. A. Carr,
4 all of Thomaston, Maine, their associates and successors,
5 are hereby constituted a body politic and corporate by the
6 name of the Georges River Land Company of Thomaston,
7 Maine, with all the rights, powers and privileges, and
8 subject to all the duties and liabilities provided by the
9 laws of this State thereto applicable.

SECT. 2. Said corporation is authorized to purchase,
2 rent, or in any legal mode acquire and hold, lease, sell and

3 convey real and personal estate and property, in their own
4 right, and in trust, as they deem expedient, or for the pur-
5 poses of said corporation; to make all necessary by-laws,
6 rules and regulations, for the furtherance of the purposes
7 of this act and the government of said corporation, not
8 inconsistent with the laws of the State.

SECT. 3. Said corporation is authorized to lease, at any
2 time, any part or all of its property or franchises; pur-
3 chase, erect or lease, furnish and carry on and maintain,
4 or lease to others to carry on, a hotel, and mortgage the
5 same, as may be deemed for the interest of the associa-
6 tion; purchase, erect or lease cottages, and all other
7 buildings that may be needed or in any way necessary for
8 the comfort or convenience of the proprietors or their
9 lessees; to recover in trust any money or property for
10 the purpose of erecting and leasing cottages and all other
11 buildings that may be in any way necessary or desired for
12 the shelter, comfort or convenience of persons residing or
13 sojourning in Maine, for health, recreation or business,
14 on the land that may be owned or leased, by said corpora-
15 tion, or put into its control as trustee as aforesaid; build
16 and maintain wharves and landings, lay out, improve and
17 ornament roads, walks and any land of said corporation;
18 may own and operate conveyances by land or water, to
19 and from and upon any lands owned or leased by said
20 corporation; lay cables under the water from any islands
21 in which said company have any interest to the main land,
22 for telephone or telegraph lines, or for electric light and
23 power, and may erect poles and use electricity for the
24 purpose of lighting and power, along any highway, for their
25 own property, or for those desiring to use the same, and

26 may make and establish all rules and regulations necessary
27 for the protection of said cables.

SECT. 4. The capital stock of said corporation shall
2 be such an amount as the stockholders, by a majority vote
3 of those present and voting shall determine from time to
4 time, not exceeding five hundred thousand dollars, said
5 stock to be divided into the number of shares, and of the
6 par value, as the directors shall determine.

SECT. 5. Either of the first three corporators named in
2 this act, or, if they are deceased, any person named as cor-
3 porator, may call the first meeting of said corporation for
4 the purpose of organization, by giving written notice
5 thereof to each of the other corporators, of the time and
6 place of meeting, by mailing the same to such corporator
7 at his usual place of abode, fifteen days, at least, before
8 said meeting.

SECT. 6. This act shall take effect when approved.
