IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED  
AND NINETY-ONE.

### An Act additional to and amendatory of the charter of the Eastport Water Company.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows :*

SECTION 1. The mortgage issued by the “East-  
2 port Water Company” to the Massachusetts Loan  
3 and Trust Company, as trustees, bearing date the  
4 twenty-seventh day of March eighteen hundred and  
5 eighty-eight, and the bonds secured thereby to the  
6 amount of eighty thousand dollars, are hereby rati-  
7 fied and made valid.

SECT. 2. The fourth section of the act entitled  
2 an act to amend the charter of the “Eastport Water

3 Company," approved March 9th, A. D. 1889, is  
4 hereby amended so as to read as follows: Said  
5 corporation is hereby authorized to issue from  
6 time to time its mortgage bonds not exceeding in  
7 all the sum of two hundred thousand dollars,  
8 (\$200,000.00) with such rates of interest and pay-  
9 able at such times as it may from time to time  
10 deem expedient, and it may apply the proceeds  
11 thereof to liquidating its present or future indebt-  
12 edness, completing, improving or extending its  
13 works, or for any other lawful uses of the corpora-  
14 tion. Any stockholder shall have the privilege of  
15 purchasing any of said bonds to the extent and in  
16 proportion that his stock bears to the whole capi-  
17 tal stock of said company at the lowest cash price  
18 at which said bonds are voted to be disposed of  
19 from time to time.

SECT. 3. All the proceedings of the adjourned  
2 meeting of the stockholders of "The Eastport  
3 Water Company" held in the first day of October,  
4 eighteen hundred and ninety are hereby ratified  
5 and made valid.

SECT. 4. All acts or parts of acts inconsistent  
2 herewith, are hereby repealed.

SECT. 5. This act shall take effect when  
2 approved.
