## IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-ONE.

AN ACT to amend the Act incorporating the Mattawamkeag Log Driving Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Section 2 of the act to provide for 2 the mode of collecting tolls and making assess-3 ments by the Mattawamkeag Log Driving Com-4 pany approved March 7, 1881, is amended as 5 follows: By striking out the word "four" in the 6 second line of said section and inserting instead 7 thereof the words 'not exceeding twenty,' and by 8 striking out in the sixth line of said section the 9 word "four" and inserting instead thereof the word

10 'twenty,' so that the whole section thus amended 11 shall read as follows:

'A toll is hereby granted to said Mattawamkeag 13 Log Driving Company of not exceeding twenty 14 cents for each thousand feet of logs, board meas-15 ure, boom scale, so-called, which may pass over 16 their dam and works, formerly owned by the 17 Mattawamkeag Dam Company, but the said Log 18 Driving Company each year may require less than 19 said twenty cents toll for that year, and said Log 20 Driving Company shall have a lien on each mark 21 of logs for the payment of all the toll of such mark, 22 and if the toll be not paid within ten days after the 23 logs, or a major part of them, arrive at the Penob-24 scot boom the said Company may advertise and 25 sell so much of said lumber of any mark as may be 26 necessary to pay the toll and expenses of such 27 mark, the notice of such sale to be published in 28 some newspaper in Bangor at least ten days before 29 the sale.'

SECT. 2. This act shall take effect when approved.
