STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-ONE.

AN ACT additional to "An Act to incorporate the Heron Lake Dam Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Whereas under the authority con-

- 2 ferred by the second section of said act incorpo-
- 3 rating said Company, it built a dam on the Allegash
- 4 river below Churchill lake, which is not now used
- 5 in connection with getting logs and lumber into
- 6 Chamberlain lake, and thence down Penobscot 7 river.

Now until said dam shall be again wanted for the 9 purpose of getting logs and lumber into Chamber-

10 lain lake, and thence down the Penobscot river, 11 the said Company is hereby authorized and em-12 powered to rebuild or repair said dam and maintain 13 it at such a height as shall facilitate the passage 14 of logs and lumber northward over said dam and 15 thence down the Allegash and St. John rivers.

Sect. 2. The said Company shall be entitled to

2 demand and receive a toll of twenty-five cents per 3 thousand feet, board measure, on all logs and 4 lumber passing over or through its said dam north-5 ward, said toll to continue until the cost of repairing 6 or rebuilding said dam and maintaining the same, 7 with interest at six per cent, shall have been repaid. To secure said toll said Company shall have a 9 lien on all logs and lumber which may pass said 10 dam as aforesaid, and if the same shall not be paid 11 within ten days after the arrival of the logs or 12 lumber on which the same shall be due, or the 13 greater portion thereof at Fredericton boom, the 14 said Company may advertise the sale of logs and 15 lumber to pay the toll and incidental expenses 16 three weeks successively in one of the newspapers 17 printed in Bangor, Maine, and in one of the news-18 papers printed in Fredericton, New Brunswick, 19 the last publication to be at least ten days before 20 the time appointed for such sale, and if payment 21 shall not be made before the time appointed, said 22 Company may proceed to sell logs and lumber to 23 pay said toll and incidental expenses, but only the 24 logs of any particular mark shall be holden and 25 sold for the toll of such particular mark; and 26 should a sum be realized from the sale of such logs 27 and lumber in excess of the amount of such toll 28 and incidental expenses, such excess shall be paid 29 by said Company to the owner of the logs and 30 lumber sold.

SECT. 3. Whenever said dam shall be again 2 wanted in connection with getting logs or lumber 3 into Chamberlain lake, and from thence down the 4 Penobscot river, said Company may raise said dam 5 so far as shall be necessary for that purpose, and 6 restore and repair the other works and improve-7 ments authorized for said purpose by said act 8 incorporating said Company and acts additional 9 thereto, and in that case said Company shall be 10 entitled to demand and receive the same toll on all 11 logs and lumber which may pass over and through 12 its dams, locks and works into Chamberlain lake, 13 as was granted it in and by an act approved March 14 19, 1860, entitled "An act additional to an act to 15 incorporate the Heron Lake Dam Company."
