STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-ONE.

AN ACT to amend section two of chapter one hundred and
forty-one of the Private and Special Laws of eighteen
hundred and eighty-seven, relating to Phillips Village
Corporation.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. Section two of chapter one hundred and
2 forty-one of the Private and Special Laws of eighteen
3 hundred and eighty-seven, is hereby amended by inserting
4 after the word "department" in the ninth and tenth lines
5 the following: "and to erect and maintain lamp-posts
6 and lamps and provide for lighting the streets within the
7 limits of said corporation and to make contracts with any
8 persons or corporations for said purposes and it may
9 authorize its assessors to make such contracts which shall

10 be binding on said corporation' so that said section as
11 amended shall read as follows :

‘SECT. 2. Said corporation is hereby invested with
2 power, at any legal meeting called for the purpose to
3 raise such sums of money as may be sufficient for the
4 support of a suitable number of hydrants, in case water
5 is brought into its limits in a suitable manner and sufficient
6 quantity, and suitable fire engines, engine houses, hose,
7 buckets, hooks and ladders, and provide a sufficient quan-
8 tity of water in the different parts of said corporation for
9 the extinguishment of fire and for organizing and main-
10 taining within its limits an efficient fire department; and
11 to erect and maintain lamp-posts and lamps and provide
12 for lighting the streets within the limits of said corporation
13 and to make contracts with any persons or corporations
14 for said purposes, and it may authorize its assessors to
15 make such contracts which shall be binding on said corpo-
16 ration, and no money shall be raised for any other purpose
17 except as above specified.’
