STATE OF MAINE.

RESOLVE in favor of the Maine General Hospital.

Resolved, That there be and hereby is appropriated the sum of seven thousand five hundred dollars (\$7,500) to be paid to the Maine General Hospital for use of said institution for the year 1891 and seven thousand five hundred dollars (\$7,500) for use of said institution for the year 1892.

STATEMENT OF FACTS.

An extension of the hospital buildings is now in progress and approaching completion which will double the capacity of the institution for service to the people of the State and render necessary an increased annual appropriation in aid of the expense of maintaining the hospital.

The work of the hospital since its establishment is shown by the following table :
