### STATE OF MAINE.

#### IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-ONE.

AN ACT to incorporate the Augusta City Hospital.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

F. 21 Blackman, their associates and successors, are hereby 22 incorporated and made a body politic by the name of the 23 Augusta City Hospital, and by that name may sue and be 24 sued, may have a common seal, and shall have all the 25 immunities and privileges and be subject to all the liabili-26 ties of like corporations.

SECT. 2. Said corporation may take, receive, purchase, 2 hold and possess lands and tenements in fee simple or 3 otherwise, and dispose of and sell the same, and may 4 receive of and from all persons disposed to aid its benev-5 olent purposes any grants and devises of real estate, and 6 any donations, subscriptions and bequests of money or 7 other property, to be used for the erection, support and 8 maintenance of a general hospital for the sick, to be 9 located within the city of Augusta.

SECT. 3. The said corporation shall have the power to 2 make and establish such by-laws and regulations as may be 3 necessary for the choice of proper officers, to prescribe 4 their duties and powers, and to provide generally for the 5 internal government and economy of the hospital, such by6 laws and regulations not being repugnant to the constitu-7 tion and the laws of this State.

SECT. 4. The said corporation is authorized to estab-2 lish a training school for nurses, and to issue such diplo-3 mas as shall be fit and proper.

SECT. 5. This act shall take effect when approved.
