STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-ONE.

AN ACT to incorporate the Bar Harbor Village
Improvement Association.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

SECTION 1. Parke Goodwin, Fred C. Lyman
2 William H. Sherman, Morris K. Jesup, Robert

11 Abbie A. Potter, Francis M. Conners, John E.

13 and their associates and successors are hereby in-
14 corporated under the name of the Bar Harbor Vil-
15 lage Improvement Association, for the purpose of
16 instituting and maintaining public improvements
17 in the Village of Bar Harbor and other parts of
18 Mount Desert Island.

SECT. 2. For the purposes of its incorporation
2 this association may receive and hold real and per-
3 sonal property not exceeding \$50,000 in amount;
4 make contracts to be binding upon itself, but not
5 upon its individual members; and to make by-laws
6 not inconsistent with law for the regulation of its
7 membership and its government.

SECT. 3. The first meeting of this corporation
2 may be called by any one of the above associates by
3 a notice published two weeks successively before
4 the time of said meeting in any newspaper pub-
5 lished at Bar Harbor.

SECT. 4. This act shall take effect when approved.
