STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-ONE.

AN ACT to amend section fifty-four of chapter forty of the Revised Statutes, relating to the transportation of trout, togue and land-locked salmon, as amended by chapter 271 of the laws of eighteen hundred and eighty-five.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Section fifty-four of chapter forty of the
2 Revised Statutes as amended by chapter two hundred and
3 seventy-one of the laws of eighteen hundred and eighty-
4 five is hereby amended by striking out the word "fifty"
5 in the third and eighth and twelfth lines of said section,
6 and inserting in its place in each of said lines the words

7 'twenty-five,' so that said section as amended shall read
8 as follows :

‘Section 54. No person shall take, catch, kill or have
10 in possession, at any one time, for the purpose of trans-
11 portation, more than twenty-five pounds of land-locked
12 salmon, trout or togue, in all, nor shall any such be trans-
13 ported except in the possession of the owner thereof,
14 under a penalty of fifty dollars for the offence and five
15 dollars for every pound of land-locked salmon, trout or
16 togue, in all so taken, caught, killed, in possession or
17 transportation, in excess of twenty-five pounds, and all
18 such fish transported in violation of this section may be
19 seized, on complaint, and shall be forfeited to the prose-
20 cutor. Whoever has in possession more than twenty-five
21 pounds in all of such fish, shall be deemed to have taken
22 them in violation of this section.’

SECT. 2. This act shall take effect when approved.
