STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-ONE.

AN ACT to incorporate the Caribou Stream Improvement Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. S. W. Collins, H. D. Collins, Chas. E.

- 2 Oak, their associates and successors, are hereby constituted
- 3 a body corporate by the name of the Caribou Stream
- 4 Improvement Company, with all the rights, powers and
- 5 privileges, and subject to all the liabilities of similar cor-
- 6 porations.

SECT. 2. Said corporation may clear and remove the

- 2 natural obstructions from, deepen, widen, and straighten
- 3 the channel of the North Branch of the Caribou Stream, in
- 4 Woodland, above Allen's Mill pond, so-called, thence to

- 5 the sources of said branch, for the purpose of facilitating
- 6 the driving of logs therein, and said corporation may take
- 7 land and material along said stream, and if the damages
- 8 therefor cannot be agreed on any person entitled thereto
- 9 may recover the same in an action on the case.
 - Sect. 3. After said corporation shall have made said
 - 2 channel, or any portion thereof, floatable for log driving
 - 3 purposes, it may demand and receive twenty-five cents
 - 4 per thousand feet, board measure, for all logs, and ten
 - 5 cents per cord for all rift, which shall pass through said
 - 6 channel where so improved by said company. Said cor-
- 7 poration shall have a lien on said logs and rift, or other
- 8 timber, for said toll for sixty days after the same
- 9 shall have arrived at its place of destination, to be enforced
- 10 by attachment and action of debt.
- Sect. 4. The capital stock of said corporation shall not
- 2 exceed one thousand dollars, to be divided into shares of
- 3 one hundred dollars each.
- SECT. 5. The first meeting may be called by either cor-
- 2 porator by giving seven days notice in writing therefor to
- 3 his associates.
 - SECT. 6. This act shall take effect when approved.
