## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED  
AND NINETY-ONE.

---

AN ACT to amend sections seventy-five and forty-four of chapter two of the Revised Statutes relating to State Library.

---

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

SECTION 1. Section seventy-five of chapter two 2 of the Revised Statutes is hereby amended so as 3 to read as follows:

‘Section 75. All money appropriated by the leg- 5 islatre for the purchase of books for the state 6 library shall be expended by the librarian under

7 the direction of the governor. He shall procure  
8 such number of each volume of the Maine reports,  
9 and of the acts and resolves when published, and  
10 distribute the same to such corporations, officers,  
11 institutions and persons within the state as the  
12 legislature may designate. He shall also obtain  
13 from each department of the state government  
14 sufficient number of its published reports to trans-  
15 mit one copy thereof to each public library in this  
16 state and to such schools and other public institu-  
17 tions therein as may desire the same.'

SECTION 2. Section forty-four of chapter two  
2 of the Revised Statutes is hereby amended by  
3 striking out all of said section after the word  
4 "distributed," in the fifth line of said section, so  
5 that said section, as amended, shall read as fol-  
6 lows:

'Section 44. He shall cause the public laws  
8 passed at each session to be printed, within thirty  
9 days after the close thereof, on extra sheets, on good  
10 paper, by the publisher of each newspaper; and  
11 each printer who so publishes and distributes the  
12 laws to his subscribers shall receive ten dollars,  
13 besides one dollar for every hundred copies so dis-  
14 tributed.'
