STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-ONE.

AN ACT to amend an act relating to the Annual
Returns of Railroad Corporations, approved Jan-
uary thirtieth, eighteen hundred and ninety-one.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

SECTION 1. The act relating to the annual
2 returns of railroad corporations approved January
3 thirtieth, eighteen hundred and ninety-one is hereby
4 amended as follows :

SECT. 2. The annual returns made by each rail-
2 road corporation for the year ending June thirtieth,
3 eighteen hundred and ninety-one, shall show the
4 gross transportation receipts from September thir-

5 tieth, eighteen hundred and ninety, to June thirtieth,
6 eighteen hundred and ninety-one.

SECT. 3. The amounts to be assessed and paid
2 upon and by each railroad corporation under sec-
3 tion forty-two of chapter six of the Revised
4 Statutes and section four of the act approved
5 March thirteenth, eighteen hundred and eighty-
6 nine, entitled an act amendatory of section one
7 hundred and thirteen of chapter fifty-one of the
8 Revised Statutes and additional to said chapter,
9 relating to railroad commissioners, for the year
10 eighteen hundred and ninety-two, shall be ascer-
11 tained as follows: After determining the rate as
12 provided in section forty-two of chapter six of the
13 Revised Statutes, upon the gross transportation
14 receipts of each railroad company for the year end-
15 ing June thirtieth, eighteen hundred and ninety-
16 one, the tax provided for in section forty-two of
17 chapter six of the Revised Statutes shall only be
18 assessed upon the gross transportation receipts as
19 shown by said returns from September thirtieth,
20 eighteen hundred and ninety to June thirtieth,
21 eighteen hundred and ninety-one.
