## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-THREE.

AN ACT relating to Insurance Companies of Foreign Countries.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Foreign insurance companies incorporated

- 2 or associated under the laws of any government or state
- 3 other than the United States, or one of the United States,
- 4 shall not be licensed to do business in this State until,
- 5 beside complying with the provisions of law relating to
- 6 the admission of companies of other states, it has made a
- 7 deposit with the treasurer of this State or with the finan-
- 8 cial officer or insurance commissioner of some one of the
- 9 other states of the United States of a sum not less than
- 10 the capital or assets required of like companies organized
- 11 under the laws of other states to entitle them to admission to

- 12 this State. Such deposit must be in exclusive trust for
- 13 the benefit and security of all the company's policy holders
- 14 and creditors in the United States and may be in securi-
- 15 ties under the same restrictions as the investments of
- 16 companies of other states.
  - SECT. 2. All real estate, securities and assets of such
- 2 companies in the United States shall be held by trustees
- 3 who are citizens thereof, for the benefit of all its creditors
- 4 in the United States. These trustees shall be appointed
- 5 by such company and a certified copy of the vote by which
- 6 they are appointed, and of the deed of trust shall be filed
- 7 in the office of the insurance commissioner and he shall
- 8 have power to examine such trustees or the agents of
- 9 such company under oath, and its assets, books and
- 10 accounts in the same manner as he may examine the offi-
- 11 cers, agents, books and accounts of any company author-
- 12 ized to do insurance business in the State.
  - Sect. 3. When such foreign insurance company shall
  - 2 have complied with the foregoing provisions, and the
  - 3 insurance commissioner is satisfied that it is solvent in
  - 4 the United States, he may issue to it a license to trans-
  - 5 act business in this State upon the payment of an admis-
  - 6 sion fee of twenty dollars, and two dollars for each agent's
  - 7 certificate of authority, and he may renew the licenses of
  - 8 the company and agents, on the first day of July, annu-
- 9 ally, upon the payment of like fees, so long as he finds
- 10 the company solvent.
