STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-THREE.

AN ACT to incorporate Sebago Improvement Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- SECTION 1. George P. Wescott, John E. Warren and
- 2 William M. Bradley, their associates, successors and
- 3 assigns, are hereby incorporated under the name of Sebago
- 4 Improvement Company with all the rights, powers and
- 5 privileges, and subject to the liabilities of similar corpora-
- 6 tions.
- SECT. 2. The capital stock of said corporation shall be 2 twenty thousand (20,000) dollars.
 - SECT. 3. Said corporation is hereby authorized to
- 12 improve the Songo river, in the county of Cumberland,
 - 3 its mouths, approaches and tributaries for the purpose of

- 4 navigation, and for this purpose to widen, deepen, and
- 5 remove obstructions from said river, its mouths, ap-
- 6 proaches and tributaries and to construct dams, canals,
- 7 locks, breakwaters and piers, and to make such other
- 8 improvements in said river, its mouths, approaches and
- 9 tributaries, as may be necessary and proper to facilitate
- 10 navigation therein. Provided, however, that any dams
- 11 built or maintained by said company shall contain proper
- 12 sluice ways for logs.
 - SECT. 4. Said corporation is hereby authorized to
 - 2 acquire for the purposes aforesaid, by purchase, grant or
 - 3 gift, from any person or corporation, and all other cor-
 - 4 porations are hereby authorized to grant to said Sebago
 - 5 Improvement Company for the purposes aforesaid, any
 - 6 lands, water rights, franchises and other property. Said
 - 7 corporation may also, for the purposes aforesaid, take
 - 8 any land or materials upon payment therefor, reasonable
 - 9 compensation to be ascertained in the same manner and
- 10 under the same conditions as are provided in the cases
- 11 of laying out public highways; and for any damage by
- 12 flowage said corporation shall make reasonable compensa-
- 13 tion to the parties injured, to be ascertained in the same
- 14 manner as now provided by law in the case of flowing
- 15 lands by erection of dams and mills.
- SECT. 5. After the improvements contemplated by this
- 2 act shall have been made in said river, its mouths and
- 3 approaches, the said corporation may demand and receive
- 4 reasonable tolls for passage through its locks of steam-

- 5 boats and other boats and vessels, but not to exceed the
- 6 tolls in force in the year 1891.
 - SECT. 6. Nothing in this act contained shall be held to
- 2 confer authority to either raise or lower the level of Lake
- 3 Sebago.
 - SECT. 7. This act shall take effect when approved.
