## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-THREE.

AN ACT to incorporate the Lubec Telephone and Telegraph Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Bion M. Pike, Clarence H. Clark, James

- 2 H. Gray, Charles J. Staples, Frank M. Tucker, Henry P.
- 3 Gillise, Jacob C. Pike and Robert G. McBride, their
- 4 associates, successors and assigns are hereby created a
- 5 body politic by the name of the Lubec Telephone and
- 6 Telegraph Company with all the powers, rights and
- 7 privileges and subject to all the duties and obligations
- 8 granted and prescribed by the General Laws of the State
- 9 relating to corporations.

- SECT. 2. Said corporation is hereby authorized to own,
  2 construct, maintain and operate a line or lines of tele3 phone and telegraph from some point in the town of
  4 Lubec in the County of Washington through the towns
- 5 of Trescott and Whiting to some point in the town of
- 6 East Machias, all in said County of Washington, upon
- 7 and along any public highway, railroad, bridge, or pri-
- 8 vate lands, and subject to the provisions of chapter three
- 9 hundred and seventy-eight of the Public Laws of eigh-
- 10 teen hundred and eighty-five, but in such manner as not
- 11 to incommode or endanger the customary public use
- 12 thereof, with the right to cut down trees and remove
- 13 obstacles, when necessary, within the limits aforesaid,
- 14 except ornamental, fruit or shade trees, and with the
- 15 power to establish and collect tolls on said line or lines.
- SECT. 3. If the land of any individual or corporation
- 2 is taken under this act, and the parties cannot agree on
- 3 the damage occasioned thereby, they shall be estimated,
- 4 secured and paid in the manner provided in case of land
- 5 taken for railroads.
  - SECT. 4. Said corporation is hereby authorized and
  - 2 empowered to connect its line or lines with those of any
  - 3 other telephone or telegraph company or corporation or
  - 4 to sell or lease its line or lines of telephone and property
  - 5 and telegraph and property, either before or after com-
  - 6 pletion to any other telephone or telegraph company or
  - 7 corporation, upon such terms as may be mutually agreed
  - 8 upon, which sale or lease shall be binding upon the

- 9 parties; or may purchase or lease any other line or lines
- 10 of telephone or telegraph upon such terms and conditions
- 11 as may be mutually agreed upon.
  - SECT. 5. The amount of the capital stock shall be fixed
  - 2 by vote of the corporation, but not to exceed the amount
  - 3 that may from time to time be considered to be necessary
  - 4 for the sole purpose of owning, constructing, maintaining
  - 5 and operating the line or lines of telephone and telegraph
  - 6 hereby authorized or contemplated, but not to exceed
  - 7 fifty thousand dollars, and said corporation may purchase,
  - 8 hold, sell and convey real estate and personal property
  - 9 necessary for the purposes contemplated in this charter.
  - SECT. 6. The said company is authorized to issue its
- 2 bonds upon such rates and time, and in such amount as it
- 3 may deem expedient, and secure the same upon its fran-
- 4 chise and property.
- SECT. 7. Any two or the corporators named in this act
- 2 may call the first meeting of the corporation by mailing
- 3 a written notice, signed by both, postage paid, to each
- 4 of the other corporators, seven days at least before the
- 5 day of the meeting, naming the time, place and purpose
- 6 of such meeting, a president, secretary, treasurer and
- 7 directors may be chosen, by-laws adopted, present amount
- 8 of capital stock fixed, and any corporate business transacted.
  - SECT. 8. This act may be accepted at any regular meet-
- 2 ing of said association by a majority of the members
- 3 present.
  - SECT. 9. This act shall take effect when approved.
