STATE OF MAINE.

RESOLVE in favor of aid in building a highway bridge across the Penobscot River between the village of Winn and the town of Chester.

Resolved, That the sum of ten thousand dollars be and

- 2 is hereby appropriated for the year 1894 to aid in build-
- 3 ing a highway bridge across the Penobscot river between
- 4 the village of Winn and the town of Chester. Said
- 5 bridge is to be built of iron with a sidewalk and roadway
- 6 not less than sixteen feet in width, and stone abutments
- 7 and piers and first class work throughout the whole
- 8 structure. The work is to be done under the supervision
- 9 of a competent bridge engineer and the amount herein
- 10 appropriated is to be paid on receipt by the State
- 11 treasurer of a certificate of the county commissioners of
- 12 Penobscot county that the said bridge has been properly
- 13 constructed and completed ready for public use.

STATEMENT OF FACTS.

Public necessity requires a highway bridge across the Penobscot river, between the village of Winn and the town of Chester, and the inhabitants are wholly unable to bear the The estimated cost made by a competent engineer for a first-class iron bridge with sixteen feet or more roadway, sidewalks and first-class stone abutments and piers, is \$22,500. The appropriation of \$10,000 by the State and \$5,000 by individual subscription, which as assured, will enable the towns to raise the balance and build the bridge, and with a bridge guaranteed, the Winn Water and Power Company, duly organized, and holding a legislative charter, assure the building of a good and substantial dam across said river, and capitalists from another State hold themselves in readiness to invest \$250,000 adding wealth and taxable property to our State. The water power at Winn is excelled by none in Maine, as regards power and railroad facilities.

MAJORITY REPORT.

The majority of the committee on Ways and Bridges, to whom was referred the petition of W. L. Scribner and others for appropriation for bridge connecting towns of Winn and Chester, in Penobscot county, praying that an appropriation of ten thousand dollars be made for a highway bridge over the Penobscot river, connecting the towns of Winn and the town of Chester or the plantation of Woodville, have had the same under consideration and ask leave to report a resolve, which is herewith submitted, entitled "Resolve in favor of aid in building a bridge across the Penobscot river between the village of Winn and the town of Chester."
