STATE OF MAINE.

RESOLVE laying a Tax on the Counties of the State for the years eighteen hundred and ninety-three and eighteen hundred and ninety-four.

Resolved, That the sum annexed to the counties in the following schedule is hereby granted as a tax on each county respectively, to be appropriated, assessed, collected and applied to the purposes of paying the debts and necessary expenses of the same, and for other purposes ordered by law, for the year one thousand eight hundred and ninety-three: Androscoggin, thirty-two thousand dollars; Aroostook, thirty-two thousand, six hundred and fifty dollars; Cumberland, seventy-five thousand dollars; Franklin, eleven thousand dollars; Hancock, nineteen thousand five hundred dollars; Kennebec, thirty-five thousand dollars; Knox, twenty thousand dollars; Lin-

14 lars ; Oxford, eleven thousand dollars ; Penobscot, twen-
