STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-THREE.

AN ACT authorizing the city of Bangor to construct a bridge over Kenduskeag stream, near the European & North American Railroad bridge.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows.

Section 1. The city of Bangor is hereby authorized to

- 2 lay out a public highway from Broad street, so called, to
- 3 Exchange street, so called, in said Bangor, northerly of
- 4 the railroad bridge crossing the Kenduskeag stream near
- 5 its junction with the Penobscot river, and build a bridge
- 6 across the said Kenduskeag stream, for foot and carriage
- 7 travel, near to and at such distance from said railroad
- 8 bridge that said railroad bridge and the bridge hereby
- 9 authorized shall not unreasonably endanger each other or

- 10 hinder the free use of either. Provided, that before lay-
- 11 ing out said highway and building said bridge, the ques-
- 12 tion of so doing shall be submitted to the registered
- 13 voters of the city of Bangor at one of the regular city or
- 14 State elections, by a yea and nay vote.
 - SECT. 2. The piers constructed by virtue of this act
 - 2 for the bridge and way hereby authorized shall be placed
 - 3 in such position in said stream as to be directly in line
 - 4 with the piers now under the railroad bridge referred to
 - 5 in section one, and the spans of said bridge shall be of
 - 6 substantially the same length as said railroad bridge, to
 - 7 the end that the use of said stream for boating and
 - 8 vessels, and for driving and hauling rafts of logs and
 - 9 lumber shall not be unreasonably obstructed by the piers
- 10 thus erected, and said bridge shall be at least three feet
- 11 higher than the present railroad bridge.
 - SECT. 3. Said city of Bangor shall construct a suffi-
 - 2 cient draw in said bridge, in line with the draw now in
 - 3 said railroad bridge, and in such manner, that the draws
 - 4 of both bridges may be used in the most convenient man-
 - 5 ner for the accommodation of navigation, for vessels, scows,
 - 6 rafts of logs and lumber; and shall at all times when it
- 7 is necessary, during such portions of the year as said
- 8 stream is open to navigation, keep a man upon said
- 9 bridge to attend said draw and open and close the same
- 10 for the passage of vessels, scows, rafts of logs and
- 11 lumber.

- SECT. 4. The city of Bangor is hereby authorized by
- 2 its city council to take and condemn such land and prop-
- B erty as may be necessary for the use of the highway, and
- 4 the construction and maintenance of the bridge hereby
- 5 authorized, and in taking and condemning such property
- 6 the same proceedings shall be had as is now provided by
- 7 the city charter and amendments thereto, for the laying
- 8 out of streets and highways in the city of Bangor, and
- 9 the right of appeal from the sums assessed for benefits
- 10 and awarded for damages shall be the same as is provided
- 11 by the city charter and amendments thereto in cases of
- 12 laying out streets and highways.
- Sect. 5. Said bridge shall be constructed and opened
- 2 to the public and forever maintained by the city of Bangor
- 3 as a free bridge, and in a safe and convenient condition
- 4 for public travel, and under the same rules and regulations
- 5 that all other bridges are maintained by said city of Bangor.
 - SECT. 6. This act shall take effect when approved.
