## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-THREE.

AN ACT to incorporate the Mexico Bridge Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Henry W. Park, William M. Hall, Clark

- 2 Houston, George A. Stevens, L. H. Harlow, Hosea
- 3 Whitman and F. C. Richards, with their associates and
- 4 successors, are hereby constituted a body corporate by the
- 5 name of the Mexico Bridge Company, for the purpose of
- 6 erecting and keeping in repair a bridge over the Andros-
- 7 coggin river, within the limits of the town of Peru on one
- 8 side and the town of Mexico on the other, at such place
- 9 as said corporation may deem most practicable and con-
- 10 venient; and the said corporation shall have power to
- 11 purchase and hold such real and personal estate as may

- 12 be necessary to carry into effect said object, to prosecute
- 13 and defend suits at law, to have and use a common seal,
- 14 to make by-laws for the management of their concerns
- 15 not repugnant to the laws of this state, and to have and
- 16 enjoy all the powers and privileges incident to or usually
- 17 granted to similar corporations.
  - Sect. 2. Said bridge shall be erected across the Andros-
- 2 coggin river within the limits aforesaid, shall be constructed
- 3 of good materials, of a suitable height from the water, and
- 4 not less than eighteen feet wide, with a suitable and suffi-
- 5 cient covering or railing for the safety of passengers, and
- sufficient passage ways shall be left for the passage of
- 7 boats, rafts, logs and timber.
  - SECT. 3. A toll is hereby granted and established for
  - 2 the benefit of said corporation, according to the rates fol-
  - 3 lowing, to wit: for every foot passenger, two cents; for
  - 4 each horse and rider, six cents; for each sleigh, sled,
  - 5 cart, wagon, chaise or sulky, drawn by one beast, ten
  - 6 cents, or when drawn by two beasts, fifteen cents; and
  - 7 for each additional horse or beast beyond two, two cents:
  - 8 for each coach, chariot, cabriolet, drawn by more than
  - 9 two horses or beasts, twenty-five cents; for droves of
- 10 neat cattle and horses, three cents each; for sheep and
- 11 swine, ten cents a dozen; and no additional toll shall be
- 12 charged for persons actually travelling in said vehicles,
- 13 but this exception shall not extend to persons taken in to
- 14 avoid toll; and only one person as a driver to each team
- 15 shall be allowed to pass free of toll; and said tolls may

- 16 be commuted by this corporation with any person or cor-
- 17 poration, by taking of him or them a sum certain for à
- 18 specified time instead thereof. Persons going or return-
- 19 ing from military duty, or to or from funerals shall be
- 20 allowed to pass free of toll, or to and from public worship
- 21 on Sundays.
  - SECT. 4. At the place of collecting tolls, said corpora-
- 2 tion shall constantly expose to view a board or sign, upon
- 3 which shall be plainly printed the rates of toll aforesaid;
- 4 and whenever the toll gatherer shall be absent from the
- 5 toll-house, the gates shall be left open and the bridge toll-
- 6 free, and the toll shall commence when the bridge is first
- 7 opened to passengers.
  - SECT. 5. If said corporation shall neglect or refuse for
- 2 the term of four years from the passage of this act, to
- 3 build and complete said bridge, this act shall be null and
- 4 void.
  - SECT. 6. Any three persons named in section one,
- 2 may call the first meeting of the corporation, by posting
- 3 notice of the time, place, and purpose of meeting, in two
- 4 public and conspicuous places in said towns of Mexico and
- 5 Peru, fourteen days before the time of said meeting.
  - SECT. 7. The towns of Mexico and Peru, in the county
- 2 of Oxford, or either of them, are hereby empowered to
- 3 take stock in the Mexico Bridge Company, to the amount
- 4 of two thousand dollars each, provided the inhabitants of
- 5 said town or towns, shall, by a majority vote of those pre-

- 6 sent at a legal meeting, called for the purpose, authorize
- 7 the same.
  - SECT. 8. This corporation shall have the right to erect
- 2 and maintain piers in said river to protect said bridge
- 3 from ice or other floating substance, or to rest the spans
- 4 of said bridge upon.
  - SECT. 9. This act shall take effect when approved.
