STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-THREE

AN ACT in reference to the par value of the shares of stock
of the Atwood Lock Company.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

SECTION 1. The Atwood Lock Company, a corporation
2 duly established under the laws of the State of Maine, is
3 hereby authorized to change the par value of the shares
4 of its stock from one hundred dollars a share to ten dollars
5 a share, so that the shares of said corporation instead of
6 being one hundred shares of one hundred dollars each
7 shall be one thousand shares of ten dollars each. Such
8 change shall be effected whenever a majority of the stock-
9 holders of said corporation shall, at a meeting legally called
10 for that purpose, so vote.

SECT. 2. This act shall take effect when approved.
