## STATE OF MAINE.

---

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED  
AND NINETY-THREE.

---

AN ACT to incorporate the Lincoln Industrial and Educa-  
tional Association.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows :*

SECTION. 1. Joseph Maddocks, John H. McClintock,  
2 J. F. Dunton, Albert Murray, Freeman Boynton, S. E.  
3 Nickerson, W. E. Lewis, George B. Kenniston and R. G.  
4 Hodgdon, their associates and successors, are hereby  
5 created a corporation and body politic by the name of the  
6 Boothbay Harbor Academy, to be established and main-  
7 tained in the town of Boothbay Harbor, in the county of  
8 Lincoln, for the promotion of education, literature and  
9 science, the same to be non-sectarian in character.

SECT. 2. Said corporation is hereby vested with all the  
2 powers, rights, privileges and immunities incident to  
3 similar corporations, may have and use a common seal,  
4 prosecute and defend suits at law, make and establish  
5 by-laws and regulations for the management of its affairs  
6 and the proper government of the academy, not repug-  
7 nant to the constitution and the laws of the State, and  
8 hold estate, real and personal, which it may now have, or  
9 may hereafter receive by gift, grant, devise, purchase or  
10 otherwise, to an amount not exceeding two hundred  
11 thousand dollars.

SECT. 3. The number of trustees of said school shall  
2 not at any time be more than fifteen, nor less than seven,  
3 a majority of said board to be at all times citizens of  
4 Boothbay Harbor. A majority of the trustees shall con-  
5 stitute a quorum to do business and the persons above  
6 named, with such others as they may associate with them,  
7 not exceeding fifteen in all, shall be trustees of said cor-  
8 poration, may fill all vacancies in their board and may  
9 remove any trustee when incapable through age or other-  
10 wise, to discharge the duties of said office.

SECT. 4. All deeds or conveyances of said estate made  
2 under the direction of the trustees, in behalf of said cor-  
3 poration, and sealed with its seal, and signed and acknowl-  
4 edged by its treasurer, shall be valid in law.

SECT. 5. All male children above the age of ten years,  
2 having their usual and legal residence in the county of  
3 Lincoln, shall have the right to attend said school and have

4 all its equal privileges and advantages free of charge of  
5 tuition.

SECT. 6. The several towns in Lincoln county sending  
2 pupils to this school are hereby authorized to raise such  
3 an amount of money as they shall at their annual meeting  
4 vote, for the purpose of paying the deficiency which may  
5 appear from year to year, in proportion to the number of  
6 scholars which each town shall send to said school.

SECT. 7. Joseph Maddocks, John H. McClintock and  
2 J. F. Dunton, or any two of them, are hereby authorized  
3 to appoint the time and place for holding the first meeting  
4 of the trustees, by giving all the trustees personal notice  
5 thereof in writing, or by publishing a notice in some news-  
6 paper in the county of Lincoln, seven days previous to  
7 said meeting.

SECT. 8. This act shall take effect when approved.
