### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINE TY-FIVE.

AN ACT in aid of the completion of the St. Croix and Penobscot Railroad.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. The city of Calais and its inhabitants may 2 surrender to the St. Croix and Penobscot Railroad Com-3 pany, its assigns or trustees, its mortgage held by said 4 city upon said road and all the parts thereof, and may 5 cancel and discharge the city's mortgage, or assign it to 6 said company, or trustee or trustees for said company, at 7 the latter's option, upon condition that said railroad shall 8 be extended and completed to a junction with the Maine

9 Central Railroad near Tomah station in Washington 10 county, prior to the first day of July, 1897; provided, 11 however, that the proposition so to do shall first be sub-12 mitted to the voters of said city in the manner prescribed 13 by Revised Statutes, chapter 51, section 137, and a 14 majority of those voting shall vote in the affirmative for 15 said proposition.

After the approval of said proposition by SECT. 2. 2 the voters as aforesaid, the city council shall, upon receiv-3 ing security for the extension and completion of said rail-4 road as aforesaid, and also for the repair and making of 5 the bridge at Salmon Falls fit to receive the traffic of the 6 St. Stephens and Milltown Railroad when completed and 7 running, by bond to said city, with good and sufficient 8 sureties, to be approved by majority of the board of alder-9 men of said city, immediately cause said mortgage to be 10 delivered and paid over to said St. Croix and Penobscot 11 Railroad Company, its assigns, or trustee or trustees, and 12 said mortgages to be cancelled or assigned as aforesaid, 13 as its directors may determine; and said city may do all 14 other things necessary and proper to accomplish the pur-15 poses of this act.

SECT. 3. Said St. Croix and Penobscot Railroad Com-2 pany is authorized to receive said mortgage and the assign-3 ment of said mortgage and to hold or cancel the same.
