STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to amend chapter 30 of the Revised Statutes,
relating to the protection of Game.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

Section ten of chapter 30 of the Revised Statutes as
2 amended by section 2 of chapter 95 of the Public Laws
3 of eighteen ninety-one is hereby amended by striking out
4 all of said section after the word "dogs" in the second
5 line and inserting the following words ; 'jack lights, (so
6 called,) torches, snares, or traps, any deer or caribou for-
7 feits forty dollars for every deer or caribou so hunted,
8 caught, killed or destroyed, and be imprisoned not exceed-
9 ing sixty days ; and no person shall, between the first days
10 of January and October, in any manner, hunt, catch, kill,

11 destroy, or have in possession any deer or caribou, or
12 part thereof, taken in close time, under the same pen-
13 alty ;' so that said section as amended shall read as fol-
14 lows :

'Section 10. Whoever hunts, catches, kills or destroys
16 with dogs, jack lights, (so-called) snares, or traps, any
17 deer or caribou forfeits forty dollars for every deer or car-
18 ibou so hunted, caught, killed or destroyed, and be sub-
19 ject to imprisonment thirty days ; and no person shall,
20 between the first days of January and October, in any
21 manner, hunt, catch, kill or destroy, or have in possession
22 any deer or caribou, or part thereof, taken in close time,
23 under the same penalty.

Any person may lawfully kill any dog found hunting
25 moose, deer or caribou, or kept or used for that purpose.

Any person owning or having in possession any dog for
27 the ptrpose of hunting moose, deer or caribou, or that is
28 kept or used for such hunting, forfeits not less than twenty
29 nor more than one hundred dollars for each dog so owned,
30 kept, used or in possession.'
