STATE OF MAINE.

**IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.**

AN ACT to amend Section nine of Chapter ninety-five of the Public Laws of eighteen hundred and ninety-one, as amended by Chapter two hundred fifty of the Public Laws of eighteen hundred and ninety-three, to prohibit the killing of cow moose and fixing an additional penalty for killing bull moose, caribou and deer in close time.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section nine of chapter ninety-five of the Public Laws of 2 eighteen hundred and ninety-one, as amended by chapter 3 two hundred fifty of the Public Laws of eighteen ninety-4 three, is hereby amended as follows, by striking out all 5 of said section after the word "dogs" in the second line

6 and inserting the following words, 'jack lights, so called,
7 torches, traps or snares, any bull moose, or in any man-
8 ner hunts, catches, kills, destroys or has in his possession
9 any cow moose, or part thereof, forfeits not less than one
10 hundred nor more than five hundred dollars, for every
11 bull moose or cow moose so hunted, caught, killed, des-
12 troyed or had in possession, and be imprisoned not exceed-
13 ing sixty days; and no person shall, between the first days
14 of January and October, in any manner hunt, catch, kill,
15 destroy or have in possession any bull moose, or any part
16 thereof, taken in close time, under the same penalty,' so
17 that said section as amended shall read as follows:

 'Section 9. Whoever hunts, catches, kills or destroys
19 with dogs, jack lights, so called, snare, or traps, any bull
20 moose, or in any manner hunts, catches, kills, destroys or
21 has in possession any cow moose, or part thereof, forfeits
22 not less than one hundred nor more than three hundred
23 dollars for every bull moose or cow moose so hunted,
24 caught, killed, destroyed or had in possession, and be
25 imprisoned thirty days, and no person shall, between
26 the first days of January and October, in any manner,
27 hunt, catch, kill, destroy or have in possession any bull
28 moose, or any part thereof, taken in close time, under the
29 same penalty.'
