STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-FIVE.

AN ACT authorizing the appointment of Special Insurance Brokers.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. The insurance commissioner, upon the 2 annual payment of a fee of twenty dollars, may issue 3 licenses to citizens of this state, already agents of one or 4 more duly authorized fire insurance companies, subject to 5 revocation at any time, permitting the person named 6 therein to procure policies of fire insurance on property 7 in this state in foreign insurance companies not authorized 8 to transact business in this state. Before the person named 9 in such a license shall procure any insurance in such com-

10 panies on any property in this state he shall in every case 11 execute and file with the insurance commi-sioner an affi-12 davit that he is unable to procure, in companies admitted 13 to do business in the state, the amount of insurance nec-14 essary to protect said property, and shall only procure 15 insurance under such license after he has procured insur-16 ance in companies admitted to do business in this state to 17 the full amount which said companies are willing to write 18 on said property; provided, that such licensed person 19 shall not be required to offer any portion of such insurance 20 to any company which is not possessed of cash assets 21 amounting to at least twenty-five thousand dollars, or one 22 which has, within the preceding twelve months, been in 23 an impaired condition. Each person so licensed shall keep 24 a separate account of the business done under the license, 25 a certified copy of which account he shall forthwith file 26 with the insurance commissioner, showing the exact 27 amount of such insurance placed for any person, firm or 28 corporation, the gross premium charged thereon, the com-29 panies in which the same is placed, the date of the policies 30 and the term thereof, and also a report in the same detail 31 of all such policies cancelled, and the gross return pre-32 miums thereon, and before receiving such license shall 33 execute and deliver to the treasurer of state a bond in the 34 penal sum of five hundred dollars, with such sureties as 35 the treasurer shall approve, with a condition that the 36 licensee will faithfully comply with all the requirements

37 of this section, and will file with the treasurer of state, in 38 January of each year a sworn statement of the gross pre-39 miums charged for insurance procured or placed and the 40 gross returned premiums on such insurance cancelled under 41 such license during the year ending on the thirty-first day 42 of December next preceding, and at the time of filing 43 such statement will pay into the treasury of state a sum 44 equal to two per cent of such gross premiums, less such 45 returned premiums so reported.

SECT. 2. Chapter one hundred and forty-seven of the 2 Public Laws of eighteen hundred and eighty-seven, and 3 chapter one hundred and seventy-nine of the Public Laws 4 of eighteen hundred and eighty-nine are hereby repealed.
