STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to amend Section sixty-seven of Chapter eighty-
one of the Revised Statutes relating to attachments.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

Section sixty-seven of chapter eighty-one of the Revised
2 Statutes is hereby amended by adding at the end thereof
3 the following: 'but an attachment of real estate shall
4 expire at the end of five years from the date of filing the
5 same in the office of the register of deeds in the county or
6 district where the said real estate or some part of it is sit-
7 uated, subject to the exceptions named in this section,
8 unless the said register shall, within said period, at the
9 request of the plaintiff or his attorney, bring forward the

10 same upon the book of attachments, in which case the
11 time shall be extended for a further period of five years.
12 The register shall be entitled to the same fee for bringing
13 forward such attachment upon the said book of attach-
14 ments, as for the original entry thereof,' so that said sec-
15 tion as amended shall read as follows :

'Section 67. An attachment of real or personal estates
17 continues for thirty days, and no longer, after final judg-
18 ment in the original suit, and not in review or error ;
19 except attachments of equities of redeeming real estate
20 mortgaged or taken on execution ; or equities of redemp-
21 tion sold on execution ; or an obligee's conditional right to
22 a conveyance of real estate on execution ; or property
23 attached and replevied ; or property attached belonging
24 to a person dying thereafter, or specially provided for in
25 any other case ; but an attachment of real estate shall
26 expire at the end of five years from the date of filing the
27 same in the office of the register of deeds in the county or
28 district where the said real estate or some part of it is sit-
29 uated, subject to the exceptions named in this section,
30 unless the said register shall, within said period, at the
31 request of the plaintiff or his attorney bring forward the
32 same upon the book of attachments, in which case the
33 time shall be extended for a further period of five years.
34 The register shall be entitled to the same fee for bringing
35 forward such attachment upon the said book of attach-
36 ments, as for the original entry thereof.'
