STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to amend an act entitled "An Act to incorporate the City of Old Town."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section twenty of chapter seventy-one of 2 the Private and Special Laws of eighteen hundred and 3 ninety-one, incorporating the city of Old Town, is hereby 4 amended by striking out the words "clerk" in the second 5 line, "city clerk" in the eleventh line, "city attorney" and 6 "city marshal" in the fourth and fifth lines, and "under-7 takers" in the seventh line, and inserting after the words "truant officers" in the seventh line, the words 'members 9 of a cemetery board," then adding to said section twenty, 10 after the word "council," the following: 'The cemetery

11 board shall consist of as many members as there are 12 wards of the city; and the city council shall so fix the 13 term of office of said members that the term of one mem-14 ber shall expire each year. Said cemetery board shall 15 elect the undertakers of the city who shall hold office for 16 one year beginning the first Monday of April; but said 17 cemetery board may by a majority vote, for sufficient 18 cause remove any or all of said undertakers,' so that said 19 section when amended shall read as follows:

'Section 20. The subordinate officers of said city to be 21 elected by the city council shall be three overseers of the 22 poor, three assessors, treasurer, collector of taxes, mem-23 bers of the school board, two street commissioners, city 24 engineer, chief engineer of the fire department, street 25 superintendent, city physician, constables, truant officers, 26 members of a cemetery board, fence viewers, surveyors 27 of lumber, measurers of wood and bark, and such other 28 officers as by law are allowed to be elected by towns, 29 except as otherwise hereby provided, and also such as are 30 provided for by the by-laws or ordinances of the city.

The overseers of the poor, assessors, treasurer, mem32 bers of the school board, street commissioners, city engi33 neer, chief engineer of the fire department, members of
34 the cemetery board, street superintendent, and city phy35 sician shall be elected by written ballot; and the other
36 officers elected by the city council, may be elected by any
37 method agreed upon by said council. The cemetery
38 board shall consist of as many members as there are wards
39 of the city; and the city council shall so fix the term of
40 office of said members that the term of one member shall
41 expire each year. Said cemetery board shall elect the

- 42 undertakers of the city who shall hold office for one year
- 43 beginning on the first Monday of April; but said ceme-
- 44 tery board may by a majority vote for sufficient cause
- 45 remove any or all of said undertakers.'
 - Sect. 2. Section twenty-one of said chapter seventy-
 - 2 one is hereby amended by inserting after the word
 - 3 "appoint" in the second line, the words 'city clerk, city
 - 4 attorney, city marshal, and,' so that said section when
 - 5 amended shall read as follows:
 - 'Section 21. The mayor, with the consent of the board
 - 7 of aldermen shall appoint a city clerk, city attorney, city
 - 8 marshal and such number of police officers as shall from
 - 9 time to time be fixed by the city council; and, also, except
- 10 as otherwise hereby provided all other officers who, by
- 11 the laws of the state, may be appointed by the mayor and
- 12 aldermen of cities or by the municipal officers of towns.'
 - SECT. 3. This act shall take effect when approved.
