## STATE OF MAINE.

RESOLVE laying a tax on Counties of the State for the years eighteen hundred and ninety-five and eighteen hundred and ninety-six.

Resolved, That the sum annexed to the counties in the 2 following schedule is hereby granted as a tax on each 3 county respectively, to be appropriated, assessed, col-4 lected and applied to the purposes of paying the debts 5 and necessary expenses of the same, and for other pur-6 poses ordered by law, for the year one thousand eight 7 hundred and ninety-five. Androscoggin, thirty-five thou-8 sand dollars; Aroostook, forty-five thousand five hundred 9 dollars; Cumberland, ninety thousand dollars; Franklin, 10 twelve thousand five hundred dollars; Hancock, twenty-11 one thousand dollars; Knox, twenty-five thousand dollars; 13 Lincoln, nine thousand eight hundred seventy-five dollars;
