# IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-FIVE

AN ACT to amend Sections thirty-four and seventy-five of Chapter fifty-one of the Revised Statutes as amended by chapter two hundred and five of the Public Laws of 1893, relating to Highway crossings.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section 34 of chapter 51 of the Revised 2 Statutes, as amended by chapter 205 of the Public Laws

3 of 1893, is hereby amended as follows: by striking out

4 the word "is" in the tenth line and inserting instead there-

5 of the words 'or automatic signals are,' and also by insert-

6 ing after the word "stationed," in the eleventh line, the


7 words 'or automatic signals to be maintained' so that said

8 section as amended shall read as follows:

Section 34. When the municipal officers of a town 10 deem it necessary for public safety, that gates should be 11 erected across a way where it is crossed by a railroad, and 12 that a person should be appointed to open and close them, 13 they may make such request in writing; and in case of 14 neglect or refusal they may apply to the railroad commis-15 sioners to decide upon the reasonableness of such request, 16 who, after notice and hearing, shall decide. When they 17 decide that such a request is reasonable, or that at said 18 crossing a flag-man or automatic signals are necessary for 19 the public safety, they may, upon said application, order 20 a flag-man to be stationed or automatic signals to be main-21 tained there, instead of gates, and the corporation shall 22 comply with such order and pay the costs; when they 23 decide otherwise, the costs shall be paid by the appli-24 cants.'

SECT. 2. Section 75 of said chapter 51 of the Revised 2 Statutes, as amended by chapter 377 of the Public Laws 3 of 1885 is hereby further amended by inserting after the 4 word "gate" in the fourth line thereof the words 'or automatic signals ordered or approved by the railroad commissioners.' So that said section, as amended, shall read as 7 follows:

'Section 75. No engine or train shall be run across a 9 highway near the compact part of a town at a speed 10 greater than six miles an hour, unless the parties operating 11 the railroad maintain a flag-man, or a gate or automatic 12 signals ordered or approved by the railroad commissioners, 13 at the crossing of such highway. And no way shall be 14 unreasonably and negligently obstructed by engines, ten-15 ders or cars. The corporation forfeits not exceeding one 16 hundred dollars for every such offence.'
