STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to enable the Proprietors of the Bangor Bridge to
dispose of their Bridge Property.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. The cities of Bangor and Brewer, or either
2 of them, are authorized at the expiration of its charter
3 to purchase the bridge, property and appurtenances of the
4 Bangor Bridge Company on the payment to said company
5 of fifty thousand (\$50,000.00) dollars; or for such sum
6 as may be found as the value of said bridge, property and
7 appurtenances by a committee of three men, one to be
8 chosen by the cities of Bangor and Brewer, who shall not
9 be a resident of either of said cities, one by the Bridge
10 Company and one to be appointed by the Chief Justice of

11 the Supreme Judicial Court, the award of a majority of
12 whom shall be final and without appeal.

SECT. 2. Said commission may be requested by the
2 cities of Bangor and Brewer, or either of them, or by
3 said Bridge Company, at any time within three months
4 prior to the expiration of said company's charter; and if,
5 within thirty days after such request each of said parties
6 has not selected its member of said committee, the Chief
7 Justice of the Supreme Judicial Court shall within five
8 days thereafter appoint a member or members of said
9 committee for such delinquent party or parties, and said
10 committee thus constituted shall forthwith organize and
11 proceed to the determination of the value of said bridge,
12 property and appurtenances.

SECT. 3. But until said committee shall determine the
2 value of said bridge property and the amount thereof shall
3 be paid to said Bridge Company, the present rate of tolls
4 as established by chapter three hundred and twenty-five of
5 the laws of eighteen hundred and forty-six, shall be con-
6 tinued.

To the Senate and House of Representatives in Legislature assembled.

The proprietors of the Bangor bridge respectfully ask for an act enabling it to dispose of its bridge property and for the passage of the accompanying bill.
