STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to amend chapter 281 of the Private and Special
Laws of 1891, as amended by chapter 570 of the Private
and Special Laws of 1893, relating to fishing in McGraw
and other ponds in Kennebec county.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

SECTION 1. Section one of chapter 281 of the Private
2 and Special Laws of 1891 as amended by chapter 570 of
3 the Private and Special Laws of 1893, is hereby further
4 amended so as to read as follows :

‘Section 1. No land-locked salmon or trout shall be
6 taken by any person in any way whatever from any stream
7 tributary to any of the following named ponds situated in
8 the counties of Kennebec and Somerset, to wit : McGraw,
9 Ellis, East, North, Great, Long and Snow ponds.’

SECT. 2. Section two of said chapter 281 of the Private
2 and Special Laws of 1891 is hereby amended by inserting
3 after the word “perch” in the first, third, fifth, sixth,
4 seventh lines the words ‘or black bass,’ so that said sec-
5 tion as amended shall read as follows :

‘Section 2. No person shall take any white perch or
7 black bass from either of the ponds or streams named in
8 section one, for the purpose of sale ; and any person tak-
9 ing white perch or black bass from either of said ponds or
10 streams in any manner whatever, for the purposes of sale,
11 or who offers white perch or black bass so taken for sale,
12 or who sells or in any manner disposes of white perch or
13 black bass so taken for profit to himself or another, or
14 ships said white perch or black bass so taken to any per-
15 son outside of this state, shall be punished by a fine of
16 ten dollars for each fish so taken, sold, offered for sale or
17 shipped, as hereinbefore prohibited. The same to be
18 recovered on complaint before any trial justice, police or
19 municipal court, in either of said counties of Kennebec or
20 Somerset, one-half to the complainant and one-half to the
21 county in which said complaint is made.’
