# STATE OF MAINE.

### To the Legislature:

Chapter two hundred twelve of the resolves of eighteen hundred ninety-three, entitled a Resolve relating to paupers not having any legal settlement within the state, is as follows:

"Resolved, That the board of state assessors are hereby directed to cause an investigation to be made of the number of paupers in the several towns and cities of the state, not having any legal settlement within the state, and the amounts such cities and towns annually expend for the care of such paupers, by sending to the overseers of the poor of each town and city proper blanks of inquiry relating to the same.

They shall then report their findings to the next legislature." SENATE-No. 81.

In conformity with the above resolve, we have sent blanks to the overseers of the poor in all the cities and towns in the state and we submit herewith in tabulated form the information contained in their replies, so far as received.
