## STATE OF MAINE.

**IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED  
AND NINETY-FIVE.**

---

AN ACT to amend section one of chapter six hundred and twenty-eight, Private and Special Laws of eighteen hundred and ninety-three, entitled "An Act for the protection of Trout and Land-locked Salmon in certain waters of the Rangeley Chain of Lakes."

---

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Section one of chapter six hundred and twenty-eight of  
2 the Private and Special Laws of 1893 is hereby amended  
3 by striking out of the fifteenth and sixteenth lines the  
4 words "the bridge on said stream" and adding in place  
5 thereof the words "the mouth of the Cascade brook, so  
6 called, and on the easterly bank of said Long Pond

7 stream,' and striking out in the sixteenth and seventeenth  
8 lines of said section, the words, "nor to Cascade brook,  
9 so called, in Greenvale plantation just east of Greenvale  
10 house" and adding the words 'nor to South Bog stream,  
11 so called, from Rangeley lake up to the first quick water  
12 on said stream,' so that said section as amended shall read  
13 as follows :

'Section 1. No person shall take, catch, fish for or  
15 destroy any trout or land-locked salmon in any of the  
16 streams flowing into Rangeley lake, or in Ross pond, at  
17 any time ; nor in Round, Dodge or Kemankeag ponds,  
18 from October first to May fifteenth ; nor in the Rangeley  
19 stream from the lower wharf at the outlet of Rangeley  
20 lake to the foot of the Rangeley dam of the Union Water  
21 Power Company, at any time ; nor in Whetstone brook  
22 which flows into Kennebago stream, nor from the foot of  
23 the boulders, so called, in said stream to the head of the  
24 falls at the outlet of Kennebago lake at any time ; nor in  
25 Metalluc brook which flows into the upper Richardson  
26 lake, or in the tributaries of said brook, at any time,  
27 provided, that the above provisions shall not apply to  
28 that portion of the stream connectin Long pond and  
29 Rangeley lake, which is below the old pine stump standing  
30 above the mouth of the Cascade brook, so called, and on  
31 the easterly bank of said Long Pond stream ; nor to South  
32 Bog stream from Rangeley lake up to the first quick water  
33 on said stream.'
