STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to amend “An Act to incorporate the Harrison Mutual Fire Insurance Company.”

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section one of chapter two hundred and eighty-seven of
2 the Private and Special Laws of eighteen hundred and
3 fifty-nine as amended by chapter four hundred and twenty-
4 nine of the Private and Special Laws of eighteen hundred
5 and eighty-five is hereby amended so as to read as follows:

‘Section 1. Sumner Burnham, George Pierce, Silas
7 Blake, Philander Tolman, Charles Thomes, Samuel
8 Thomes, Benjamin F. Pierce, Amos P. Foster, Jonathan
9 Whitney, Solomon L. Andrews, John E. Dannels, John
10 Dawes, Joshua Howard, Henry Roby, Stephen Blake,
11 Edward K. Whitney, Albion K. Morse, Cyrus Haskell,

12 Thomas R. Sampson, and all others who may hereafter
13 become members of said company in manner herein pre-
14 scribed are hereby incorporated and made a body politic
15 by the name of the Harrison Mutual Fire Insurance Com-
16 pany for the purpose of insuring in the town of Harrison,
17 only provided, however, if the company so vote, they
18 shall have the right to insure in the town of Otisfield and
19 in any other town or unincorporated place in Cumberland
20 and Oxford counties in the manner hereafter described,
21 also their respective dwelling houses, stores, shops, barns
22 and other buildings, household furniture, merchandise
23 and other property against loss or damage by fire,
24 whether the same happen by accident, lightning or by any
25 other means excepting that of design in the insured, and
26 may purchase and hold such real and personal estate as
27 may be necessary to effect the object of this association
28 and may sell and convey the same at pleasure.

HOUSE AMENDMENT "A" ADOPTED BY HOUSE.

Insert in title after word "Act" in first line the words 'to amend chapter 429 of the Private and Special Laws of 1885, being an act.'

HOUSE AMENDMENT "B" ADOPTED BY HOUSE.

Strike out all after the words "Section 1" and insert the following :

Section 1 of chapter 429 of the Private and Special Laws of 1885 is hereby amended by inserting after the word "Otisfield" in the sixteenth line the following: 'Or in any town, plantation or unincorporated place in Cumberland or Oxford counties' so that said section one of said chapter 429 as amended shall read as follows :

'Section 1. Sumner Burnham, George Pierce, Silas
2 Blake, Philander Tolman, Charles Thomes, Samuel
3 Thomes, Benjamin F. Pierce, Amos P. Foster, Jonathan
4 Whitney, Solomon L. Andrews, John E. Dannels, John
5 Dawes, Joshua Howard, Henry Roby, Stephen Blake,
6 Edward K. Whitney, Albion K. Morse, Cyrus Haskell,
7 Thomas R. Sampson, and all others who may hereafter
8 become members of said company in manner herein pre-
9 scribed are hereby incorporated and made a body politic
10 by the name of the Harrison Mutual Fire Insurance Com-
11 pany for the purpose of insuring in the town of Harrison,
12 only provided, however, if the company so vote they shall
13 have the right to insure in the manner hereafter described
14 in the town of Otisfield or in any town, plantation, or
15 unincorporated place in Cumberland or Oxford counties,
16 also their respective dwelling houses, stores, shops, barns
17 and other buildings, household furniture, merchandise and

18 other property against loss or damage by fire whether the
19 same happen by accident, lightning or by any other means
20 excepting that of design in the insured and may purchase
21 and hold such real and personal estate as may be neces-
22 sary to effect the object of this association and may sell
23 and convey the same at pleasure.'
