### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-FIVE.

AN ACT to amend the charter of the Bangor, Orono and Old Town Railway Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section thirteen of chapter one hundred 2 and sixteen of the Private and Special Laws for the year 3 one thousand eight hundred and ninety-one is hereby 4 amended by adding thereto the following: 'Any street 5 railroad company whose lines as constructed or chartered 6 would form connecting or continuing lines with the lines 7 of this company is hereby authorized to consolidate with 8 or to lease or sell its lines, property and franchises as in 9 this section authorized,' so that said section as amended 10 shall read as follows:

'Section 13. Said corporation is hereby authorized to 12 lease all of its property and franchises on such terms as it 13 may determine. Also to consolidate with or to acquire by 14 lease, purchase or otherwise, the lines, property and fran-15 chises of any other street railroad whose lines as con-16 structed or chartered would form connecting or continuing 17 lines with the lines of this company, and in such case this 18 corporation shall be entitled to all the privileges and be 19 subject to all appropriate conditions and limitations con-20 tained in the charters thus united with or acquired. 21 Wherever any person or corporation shall be lawfully 22 operating any street railway to any point to which this 23 corporation's tracks extend, this corporation may enter 24 upon, connect with, and use the same on such terms and 25 in such manner as may be agreed upon between the par-Any street railroad company whose lines as con-27 structed or chartered would form connecting or continuing 28 lines with the lines of this company is hereby authorized 29 to consolidate with or to lease or sell its lines, property 30 and franchises as in this section authorized.'

- SECT. 2. Said corporation, for the purposes of this 2 amendatory act, is authorized to issue its bond in the same 3 manner as authorized by section twelve of its existing 4 charter.
- SECT. 3. The time within which the said corporation is 2 required by general law to actually commence business is 3 hereby extended six months.
  - SECT. 4. This act shall take effect when approved.
