AMENDMENTS TO HOUSE BILL No. 144.

By striking out in the eighty-third line of the first sec-2 tion the word "Elizabeth," where it first occurs in said 3 line, and substituting therefor the words 'South Portland,' 4 also by striking out in said line eighty-three the words 5 "new town of" after the word "said" and inserting in lieu 6 thereof the words 'towns of South Portland and Cape 7 Elizabeth.'

By substituting for section three of said bill the following:
 'Section 3. The existing liabilities of the present town
10 of Cape Elizabeth, shall be divided as follows:—The town
11 debt shall be borne by said towns in proportion to the
12 valuation of taxable property and estate within their

13 respective territories, as taken by the assessors in April 14 eighteen hundred and ninety-four; and shall continue to 15 pay the same proportion of the state and county taxes 16 assessed upon the present town of Cape Elizabeth, until a 17 separate valuation shall be made by the state assessors. 18 All paupers now supported or aided by the present town 19 of Cape Elizabeth, or that may hereafter become charge-20 able as paupers, shall, after division, be chargeable to and 21 maintained and supported by the new town of Cape Eliza-22 beth, or the town of South Portland, according as their 23 last settlement may fall within the respective territories of 24 said towns.'

By substituting for section four of said bill the following:
'Section 4. All town property, real and personal, now
27 situated within the limits of said new town of Cape Eliza28 beth, shall become the property of said new town, and all
29 town property real and personal now situated within the
30 limits of said town of South Portland, shall become the
31 property of said town of South Portland.'

To amend section five by striking out in the second line 33 the word "Elizabeth" where it last occurs in said line and 34 inserting in lieu thereof the words 'South Portland.'

To amend by substituting for section six the following:
 'Section 6. The selectmen for the present town of Cape
37 Elizabeth shall have full power and authority, and be
38 required to call, upon petition as now provided by statutes
39 relating to calling town meetings, the first annual meeting

- 40 for said new town of Cape Elizabeth, and town of South 41 Portland.'
- SECT. 8. All by-laws now in force in the present town 2 of Cape Elizabeth shall continue to be the by-laws of the 3 town of South Portland.
 - SECT. 9. This act shall take effect when approved.
