## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-FIVE.

AN ACT to incorporate the York County Medical Society.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Lora D. Dennett, Walter T. Goodale,

Bourne of Kennebunk, all in 15 the county of York and State of Maine, their associates, 16 successors and assigns, are hereby created a body politic 17 and corporate, by the name of the York County Medical 18 Society.
- SECT. 2. The object of the society shall be to promote 2 the study and practice of medicine and surgery, and to 3 create and maintain a more intimate acquaintance and 4 friendship among the physicians of York county.
- SECT. 3. Said corporation may purchase and hold real 2 estate and personal property to an amount not exceeding 3 at any one time twenty-five thousand dollars, with full 4 power to manage and dispose of the same, shall have power 5 to prosecute and defend suits at law and in equity, and to 6 be governed by a code of by-laws not inconsistent with the 7 laws of the State.
- SECT. 4. The first meeting of said corporation may be 2 called by any three of the corporators, by a notice specify-3 ing the time and place of such meeting, published in any 4 paper in the city of Biddeford, at least one week prior to 5 the time fixed for said meeting.
  - SECT. 5. This act shall take effect when approved.
