STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to incorporate the Maine Christian Conference.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. Cordyn M. Jewett, Ora O. Crosby, J. W.
2 Webster and B. T. Reed, their associates and successors
3 are hereby constituted a corporation for religious, mis-
4 sionary and educational purposes under the name of the
5 Maine Christian Conference, and by that name shall have
6 power to prosecute and defend suits at law, to use a com-
7 mon seal, to take and hold for the objects of their associ-
8 ation by gift, grant, bequest, purchase or otherwise, any
9 estate real or personal, or both, the annual income of
10 which shall not exceed twenty thousand dollars, and to

11 sell and convey any estate real or personal or both, which
12 the interests of said corporation may require to be sold
13 and conveyed.

SECT. 2. The said corporation may adopt such a con-
2 stitution as they may deem expedient for the management
3 of their affairs from time to time and they shall be and
4 they are hereby invested with all the powers, privileges,
5 rights and immunities incident to similar corporations.

SECT. 3. The Maine Central Christian Conference and
2 the Maine Eastern Christian Conference are each hereby
3 authorized and empowered to transfer and deliver to the
4 Maine Christian Conference all their real and personal
5 property and estate and existing rights to be held and
6 used by said corporation for the purposes mentioned in
7 this act and all the powers and immunities of both said
8 conferences shall vest in said Maine Christian Conference
9 together with all records and papers of both said confer-
10 ences.

SECT. 4. The first meeting of said corporation may be
2 called by Cordyn M. Jewett or by any other corporator
3 mentioned in this act by a notice of the time and place
4 being sent to each corporator at least seven days before
5 said meeting.

SECT. 5. This act shall take effect when approved.
