## STATE OF MAINE.

#### IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-SEVEN

AN ACT for the promotion of Medical Education and the prevention of unauthorized uses of and traffic in Dead Human Bodies.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. The professors of anatomy, the professors of 2 surgery, and the demonstrations of anatomy in the medical 3 schools of this State, which are now or may hereafter 4 become incorporated by act of the legislature, shall be and 5 are hereby constituted a board for the collection, distribu-6 tion, and delivery of dead human bodies hereinafter de-7 scribe, to and among such persons as under the provisions

8 of this act are entitled thereto. The professor of anatomy 9 in the medical school of Maine shall call a meeting of said 10 board for organization at a time and place to be fixed by 11 him within thirty days after the passage of this act. The 12 said board shall have full power to establish rules and 13 regulations for its government, and to appoint and remove 14 officers, and shall keep full and complete minutes of its 15 transactions, and record shall also be kept under its direc-16 tion of all bodies received and distributed by said board, 17 and of the persons to whom the same are distributed, which 18 minutes and records shall be open at all times to the inspec-19 tion of each member of said board, the attorney general 20 and the county attorney of any county within this State.

Sect. 2. All public officers, agents, and servants of any 2 and every county, city, town, and other municipality, and 3 of any and every almshouse, prison, morgue, hospital, or 4 any other public institution having charge or control over 5 dead human bodies, provided the deceased was at least 6 fifteen years of age, are hereby required to notify immedi-7 ately the said board of distribution, or such person or per-8 sons as may from time to time be designated by said board, 9 or its duly authorized officer or agent, whenever any such 10 body or bodies come into his or their possession, charge, 11 or control, and shall immediately notify any known mem-12 ber of the family or next of kin of the deceased, and shall, 13 if the body is not claimed, without fee or reward, forth-

14 with deliver such body or bodies to said board, or its duly 15 authorized officer or agent, and permit and suffer the said 16 board or its agents, or the physicians and surgeons from 17 time to time designated by it or them, who comply with 18 the provisions of this act, to take and remove any and all 19 such bodies to be used within this State for the advance-20 ment of medical education; but no notice need be given 21 and no such body shall be delivered, if any person, satisfy-22 ing the authorities in charge of said body that he or she is 23 a member of the family of or next of kin to the deceased, 24 shall claim the body for burial, but it shall be surrendered 25 to him or her for interment or buried at public expense 26 and no notice shall be given and no body delivered to said 27 board or its agents, if such deceased person was a traveler 28 and not a vagabond, who died suddenly, or had been a resi-29 dent of said town or city ten or more years.

Sect. 3. Said board or its duly authorized agent may take 2 and receive such bodies, so delivered as aforesaid, and shall 3 upon receiving them after seven days from the date of 4 decease distribute and deliver them to or among the schools, 5 physicians and surgeons aforesaid in the following man-6 ner: Those schools needing bodies for lectures and demon-7 strations shall first be supplied as fast as practicable, the 8 number assigned to each to be based upon the number of 9 students in actual attendance, which number shall be 10 returned to the board at such times as it shall direct. The

11 board of distribution may from time to time designate12 physicians or surgeons who shall receive said bodies, appli-13 cations to be considered in the order of their receipt by14 said board.

Sect. 4. The said board may employ a carrier or carriers 2 for the conveyance of said bodies, and the said bodies shall 3 be well enclosed within a suitable encasement, and carefully 4 deposited free from public observation. Said carrier shall 5 obtain receipts by name, or, if the deceased is unknown, by 6 a description, for each body delivered by him, which receipt 7 shall state the source from which said body was received, 8 and shall deposit said receipts with the secretary of said 9 board.

Sect. 5. No school, physician or surgeon shall be allowed 2 or permitted to receive any such body or bodies until a 3 bond shall be given to the State treasurer by such physician 4 or surgeon, or by and in behalf of such school, to be 5 approved by a justice of a court of record in and for the 6 county in which such physician or surgeon resides, or in 7 which such school is situated, which bond shall be in the 8 penal sum of one thousand dollars, conditioned that all 9 such bodies which the said physician or surgeon, or the 10 said school shall receive thereafter shall be used only for 11 the promotion of medical education within the State, and, 12 when no longer needed for such educational purposes, shall 13 be decently buried, which said bond shall be examined

14 annually in the month of December, by the State treasurer, 15 and he shall certify in writing upon each bond in his pos-16 session, his approval of the same, and in case any bond is 17 not so approved by him, he shall immediately notify the 18 party giving the said bond, who shall forthwith file a new 19 bond as hereinbefore provided; and whosoever shall sell 20 or buy such body or bodies, or in any way traffic in the 21 same, or shall transmit or convey, or cause to procure to 22 be transmitted or conveyed said body or bodies to any 23 place outside of this State shall be deemed guilty of a mis-24 demeanor, and shall, on conviction, be liable to a fine not 25 exceeding two hundred dollars, or to be imprisoned for a 26 term not exceeding one year.

Sect. 6. Neither the State nor any county or municipal-2 ity, nor any officer, agent or servant thereof, shall be at 3 any expense by reason of the delivery or distribution of 4 any such body, but all the expenses thereof, and of said 5 board of distribution, shall be paid by those receiving the 6 bodies, in such manner as shall be specified by said board 7 of distribution.

Sect. 7. Any person having duties enjoined upon him by 2 the provisions of this act, who shall neglect, refuse, or 3 omit to perform the same as required by the provisions of 4 this act, shall, on conviction thereof, be liable to a fine of 5 not less than one hundred or more than five hundred dol-6 lars for each offence.

Sect. 8. Sections 2, 3, (as amended by chapter 254 of the
2 Public Laws of 1893,) 4, 5, 6, 7, and 8 of chapter 13,
3 Revised Statutes, are hereby repealed.

Sect. 9. This act shall take effect when approved.
