STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-SEVEN

AN ACT to authorize the erection of piers and booms in the Mattawamkeag River at the Oxbow.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Wilbur Grant of Kingman in the county of 2 Penobscot, his successors and assigns, are hereby authorized 3 and empowered to locate, erect and maintain in the Matta-4 wamkeag river at and below the head of Oxbow Island, so 5 called, lying between Wytopitlock and the village of King-6 man, piers and booms for the purpose of collecting, hold-7 ing, separating and sorting out logs and other lumber com-8 ing down said Mattawamkeag river. Said piers and booms

9 shall be located as follows: A sorting boom at the head of 10 Oxbow Island, so called, and a holding boom extending II from said sorting boom to the natural outlet of Mud Pond, 12 so called, below said Oxbow; and said piers and booms shall 13 be so located, constructed, maintained and used that logs and 14 lumber running down said river belonging to other parties, 15 and not destined for use and manufacture at the mills of said 16 Grant, his successors and assigns, shall not be unreasonably 17 impeded or delayed, and in no case shall logs and other 18 lumber be delayed longer than twenty-four hours; provided, 19 however, that logs and other lumber running down said river 20 in what is known as the first Mattawamkeag drive may be 21 longer delayed and detained if necessary for the purposes of 22 sorting out and turning by logs and other lumber not des-23 tined for the use and manufacture at the mills of said Grant, 24 his successors and assigns; and any stray logs and other 25 lumber not destined for use and manufacture at the mills of 26 said Grant, if found in the booms herein authorized to be 27 constructed and maintained shall be turned out thereof by 28 said Grant, his successors or assigns, upon demand of the 29 owner or owners thereof in writing at the expense of said 30 Grant, his successors and assigns.

Sect. 2. Said Grant, his successors and assigns, by aid of 2 such piers and booms are hereby authorized and empowered 3 to separate and sort out from the logs and other lumber com-4 ing down said river, all logs and other lumber destined and 5 intended for use and manufacture at the mills of said Grant;

6 provided, however, if upon the approach of the rear of any 7 drive of logs to said booms herein authorized to be con-8 structed and maintained, it shall appear to the person in 9 charge of such drive that said Grant has not sufficient men to 10 sort and turn by the logs arriving at said booms, so that such 11 drive may be unreasonably impeded or delayed, such person 12 upon notice to said Grant in writing shall have the right to 13 put men of his own selection upon said booms to expedite 14 the sorting and turning by of logs in such drive, who shall 15 be paid by said Grant, and the additional cost, if any, of mak-16 ing such drive through said booms in consequence of said 17 erections, shall be paid by said Grant, his successors or 18 assigns, but nothing herein contained shall make said Grant 19 liable for delay caused by said piers and booms. Said Grant, 20 his successors and assigns, are also hereby authorized and 21 empowered to hold within the piers and booms mentioned 22 in this act and located, erected and maintained as aforesaid, 23 all logs and other lumber running down said Mattawamkeag 24 river which are destined and intended for use and manufac-25 ture at the mills of said Grant.

Sect. 3. The Mattawamkeag Log Driving Company, a 2 corporation existing under the laws of Maine, shall have the 3 right at any time to appoint an agent who is hereby author-4 ized and empowered to take an account of all logs and other 5 lumber running into said booms, designating the number of 6 pieces and the marks thereon, and said agent shall make 7 return to the clerk of said Mattawamkeag Log Driving Com-

8 pany of all logs and other lumber running into said booms, 9 which return shall be placed upon file in the office of said 10 company and shall at all times be open to the inspection of 11 all persons interested in timber lands upon or in the driving⁻ 12 of logs down said Mattawamkeag river or any of its tribu-13 taries.

Sect. 4. Said Grant, his successors and assigns, may enter 2 upon, take and hold such lands as may be necessary for the 3 location, erection and maintenance of the piers and booms 4 mentioned in this act and connecting the same with the 5 shores, and may with his agents and teams pass and re-pass 6 over said shores and to and from the same over the lands of 7 others for the purposes aforesaid and for the operation and 8 management of said piers and booms, making compensation 9 therefor as provided in case of damage for lands taken in 10 laying out highways.

Sect. 5. Nothing in this act shall interfere with or take 2 from the Mattawamkeag Log Driving Company, any rights 3 heretofore granted said company.

Sect. 6. This act shall take effect when approved.
