STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-SEVEN

AN ACT to repeal certain old and obsolete Private and Special
Laws relating to close time for fishing in the public waters of
the State.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*
