STATE OF MAINE.

RESOLVE laying a tax on Counties of the State for the years
eighteen hundred and ninety-seven and eighteen hundred
and ninety-eight.

Resolved, That the sum annexed to the counties in the
2 following schedule is hereby granted as a tax on each
3 county respectively, to be appropriated, assessed, collected
4 and applied to the purposes of paying the debts and neces-
5 sary expenses of the same, and for other purposes ordered
6 by law.
