STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-NINE.

AN ACT to amend section one of chapter four hundred and thirtysix of the Special Laws of 1834, entitled "An Act to incorporate the City of Bangor," approved February 12, 1834.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section one of chapter four hundred and thirty-six

- 2 of the Special Laws of 1834 is hereby amended by striking out
- 3 all of said section after the word "impose" in the thirteenth line
- 4 thereof, and inserting the following words, to wit: 'Penalties
- ${f 5}$ for the breach thereof, by fine not exceeding fifty dollars and
- 6 costs for any offense to be recovered by action of debt in the
- 7 name of the city treasurer or upon complaint as for a criminal
- 8 offense; or by imprisonment not exceeding ninety days in the

9 county jail, county or city house of correction; and in default 10 of payment of fine and costs, by imprisonment in such jail or 11 house of correction not exceeding thirty days, as the court may 12 order,' so that said section as amended shall read as follows:

That the inhabitants or the town of Bangor shall 14 continue to be a body politic and corporate by the name of the 15 city of Bangor, and, as such, shall have, exercise and enjoy all 16 of the rights, immunities, powers, privileges and franchises, 17 and shall be subject to all the duties and obligations now apper-18 taining to, or incumbent on said town, as a municipal corpora-19 tion, or appertaining to or incumbent upon the inhabitants or 20 officers thereof; and may ordain and establish such acts, laws 21 and regulations, not inconsistent with the constitution and laws 22 of this state as shall be needful to the good order of said 23 body politie; and impose penalties for the breach 24 thereof, by fine not exceeding fifty dollars and costs for any 25 offense, to be recovered by action of debt in the name of the 26 city treasurer or upon complaint as for a criminal offense; or 27 by imprisonment not exceeding ninety days in the county jail, 28 county or city house of correction; and in default of payment 29 of fine and costs, by imprisonment in such jail or house of cor-30 rection not exceeding thirty days, as the court may order.'

Sect. 2. This act shall take effect when approved.
