STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND NINETY-NINE.

AN ACT to set off a part of the Town of Trescott and annex the same to the Town of Edmunds.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. All that part of the town of Trescott, in the county
- 2 of Washington and State of Maine, lying westerly of Whiting
- 3 river and Cobscook bay, so-called, together with the inhabi-
- 4 tants thereof, is hereby set off from said town of Trescott and
- 5 annexed to the town of Edmunds.
 - Sect. 2. The inhabitants aforesaid shall be holden to pay all
- 2 taxes which have been legally assessed upon them in the town
- 3 of Trescott, and the collectors of taxes for said town of Tres-
- 4 cott are authorized and required to collect and pay all the taxes

- 5 to them committed, according to their respective warrants.
- 6 All money now in the treasury of said town, and all sums
- 7 which shall hereafter be received from taxes heretofore assessed,
- 8 shall be applied to the several purposes for which they were
- 9 received.
- Sect. 3. The town of Edmunds shall pay two hundred and
- 2 fifty dollars of the town debt of said town of Trescott into the
- 3 treasury thereof on or before the first day of June, A. D. 1900,
- 4 and said town of Edmunds is hereby authorized to assess said
- 5 sum of two hundred and fifty dollars upon the property of that
- 6 part of said town of Trescott hereby annexed to said town of
- 7 Edmunds in addition to the regular current assessment of said
- 8 town of Edmunds for the year eighteen hundred and ninety-
- 9 nine.
 - Sect. 4. All paupers now supported or aided by the town of
- 2 Trescott including the insane paupers, if any, shall be main-
- 3 tained by said town of Trescott. And all persons that may
- 4 hereafter fall in distress or become paupers shall, after the
- 5 approval of this act, be maintained and supported by the town
- 6 in whose territory their settlements may be established under
- 7 the laws of the state. The school houses and lots and other
- 8 school property shall belong to the town in whose territory they
- 9 are in.
 - Sect. 5. This act shall take effect when approved.
