STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT
HUNDRED AND NINETY-NINE.

AN ACT to amend Section one of Chapter five hundred and
twenty-five of the Private and Special Laws of the year one
thousand eight hundred and eighty-five, relating to the Presque
Isle Village Fire Department.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. Section one of chapter five hundred and twenty-
2 five of the Private and Special Laws of the year one thousand
3 eight hundred and eighty-five is hereby amended so that said
4 section one as amended shall read as follows :

‘Section 1. The territory embraced within the following
6 described limits in the town of Presque Isle, in the county of
7 Aroostook, to wit: Beginning at a point where the north line

8 of the homestead farm of George M. Park intersects the south-
9 easterly bank of the Presque Isle stream ; thence running east-
10 erly along said north line to the Houlton road, so-called ; thence
11 continuing easterly in the same course as said north line to the
12 west line of the Hardy lot, so-called, said west line being the
13 east line of the Dudley and Fairfield land ; thence following
14 said west line northerly to the south line of what was formerly
15 the town of Maysville ; thence continunig northerly along the
16 east line of lots numbered two (2) and one (1) in section
17 three (3) in what was formerly said town of Maysville, to the
18 southeast corner of land now occupied by S. Walter Stevens
19 as a homestead ; thence westerly along the south line of land
20 last named to the Presque Isle stream ; thence northerly down
21 said stream to the north line of section numbered two (2) in
22 what was formerly said town of Maysville ; thence westerly on
23 said north line to the northwest corner of lot numbered two (2)
24 in said section numbered two (2) ; thence southerly on the
25 west line of said lot numbered two (2) to the south line of
26 what was formerly said town of Maysville ; thence westerly
27 along said south line to the northwest corner of lot numbered
28 two (2) in what was originally the town of Presque Isle ;
29 thence southerly along the west line of said lot numbered (2)
30 to the Presque Isle stream ; thence easterly in a straight course
31 across said stream to the place of beginning, together with the
32 inhabitants thereon, be, and the same is hereby created a body
33 politic and corporate by and under the name of the Presque
34 Isle Village Fire Department.'

Sect. 2. This act shall take effect when approved.
