## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT  
HUNDRED AND NINETY-NINE.

---

AN ACT relating to the Charter of the Wiscasset and Quebec  
Railroad.

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. The railroad location of the Wiscasset and Que-  
2 bec Railroad Company through the towns of Wiscasset, Alna,  
3 and Whitefield, in the county of Lincoln; Windsor, China,  
4 Albion, and Unity Plantation in the county of Kennebec;  
5 Burnham in the county of Waldo; and Pittsfield in the county  
6 of Somerset, as now on file in the offices of the county com-  
7 missioners of said counties of Lincoln, Kennebec, Waldo and  
8 Somerset is hereby ratified, approved and confirmed as legal  
9 and valid, and all of the acts of said railroad company in here-  
10 tofore mortgaging its property and franchises are hereby  
11 ratified, approved and confirmed as legal and valid.

Sect. 2. Said Wiscasset and Quebec Railroad Company is  
2 hereby authorized to extend, by lease of existing railroads in  
3 whole or in part, or by construction, its road from any point  
4 in its line aforesaid, which is hereby made legal and valid,  
5 in a northerly direction, by way of Hartland, to some conven-  
6 ient point on Moosehead lake or to a junction with the Bangor  
7 and Piscataquis Railroad now operated by the Bangor and  
8 Aroostook Railroad Company or to a junction with the Cana-  
9 dian Pacific Railroad. Said company is hereby given two  
10 years from the date of the approval of this act for the location  
11 and construction of its road as aforesaid, and said company  
12 shall have the same rights, privileges, powers and immunities  
13 and be subject to the same duties and liabilities in respect to  
14 the location, construction, maintenance, use and management,  
15 of the portion of the road hereby authorized to be extended  
16 and constructed as are granted and imposed by the original  
17 act incorporating said company and all acts amendatory  
18 thereof and in addition thereto.

Sect. 3. This act shall take effect when approved.
