STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT
HUNDRED AND NINETY-NINE.

AN ACT granting the Dennysville Lumber Company Addi-
tional Rights.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. The Dennysville Lumber Company of Dennys-
2 ville in the State of Maine is hereby authorized to maintain
3 their dam across the Dennys river at Dennysville, for the
4 purpose of raising a sufficient head of water to drive logs and
5 run its mills at said Dennysville, also to maintain their dam
6 across said Dennys river at Gilman's Rips in the town of
7 Charlotte, and their dam at the outlet of Meddybemps lake
8 in the town of Meddybemps, and their dam on Stony brook
9 in the town of Baileyville, and to build and maintain wing

10 dams where the same may be necessary in said Dennys river,
11 and to clear out rocks and other obstructions in said Dennys
12 river for the purpose of facilitating the passage of logs and
13 lumber down said Dennys river, with all the powers, privi-
14 leges and immunities and subject to all the duties, liabilities
15 and obligations under the general laws of the State, of cor-
16 porations to which similar powers and rights are granted.

Sect. 2. Said company may demand and receive a toll of
2 one and a half cents on each log or stick that may be driven
3 down said river from Meddybemps lake, and a toll of one
4 cent on each log or stick that may be driven down said river
5 from below said Meddybemps lake and above the Gilman
6 Rips dam, and a toll of three-fourths of a cent on each log
7 or stick that may be driven down said river from below said
8 Gilman Rips dam. And shall have a lien on all logs and
9 lumber for the payment of the tolls. And if the said toll is
10 not paid within thirty days after the passage of the logs or
11 lumber or a major part of the same, the company may adver-
12 tise such logs and lumber for sale in some newspaper printed
13 in Calais or Eastport, giving ten days' notice of the time and
14 place of sale, and sell at public auction so many of the said
15 logs and lumber as shall be necessary to pay charges and tolls.

Sect. 3. An account of the cost of all improvements and
2 repairs made subsequent to the passage of this act shall be
3 kept by the clerk or treasurer of said corporation, and when
4 the corporation shall be reimbursed with interest, by said
5 tolls, then the tolls shall be reduced to a sum sufficient to
6 keep said dams and other improvements in repair.
