STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT
HUNDRED AND NINETY-NINE.

AN ACT to repeal the Provisions of Chapter 215 of the Resolves of 1897, Appropriating twenty thousand dollars a year, for ten years, for the University of Maine, so far as the same relates to the years subsequent to 1900.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Chapter 215 of the Resolves of the year 1897, 2 so far as the same appropriates the sum of twenty thousand 3 dollars a year in favor of the trustees of the State College of 4 Agriculture and Mechanic Arts for the year 1901 and five 5 years subsequent thereto, is hereby repealed.

MAJORITY REPORT.
