STATE OF MAINE.

RESOLVE in favor of the Maine State Library for the years eighteen hundred and ninety-nine and nineteen hundred.

Resolved, That the sum of three thousand four hundred 2 dollars be and is hereby appropriated for the use of the Maine 3 State Library for the year eighteen hundred ninety-nine, and 4 that a like sum be and is hereby appropriated for the year 5 nineteen hundred, the same to be expended yearly for the 6 following purposes: For continuing sets of American, Eng-7 lish and colonial reports, digests and statutes, nine hundred 8 dollars; for subscriptions to historical, literary and scientific 9 periodicals and works, one thousand dollars; for completing 10 sets of Scotch, English, Canadian and American reports and 11 session laws, nine hundred dollars; for typewriting and cataloguing, four hundred dollars; for Maine statutes and sup-13 plements, two hundred dollars.

STATEMENT OF FACTS AND ESTIMATES.

The regular appropriation for the State library is \$1,000. This sum is not sufficient to pay the current subscriptions to periodicals, cataloguing and incidental expenses inevitably contracted in the administration of its affairs. The legislature of 1893, and every succeeding legislature has recognized this fact.

The special appropriation for 1893 was \$6,325, for 1895, \$8,000, in 1897, \$6,600. This money has been expended largely in completing broken sets of books in the library, and in the purchase of English and Canadian law reports, American statutes, and Digests, and in procuring local histories, historical and scientific works of great value.

The following estimates show the amount that seems absolutely necessary for the completion of sets of books now in the library, for the continuation of completed sets, and for work, labor and material required to run the library.
